-IF YOU BRING YOUR OWN LIQUOR, WINE, CHAMPAGNE, OR BEER - YOU MUST HAVE A BANQUET PERMIT . IF YOU CHOOSE TO HAVE THE BAR CLOSED AND OPERATE YOUR OWN BAR, **THERE WILL BE AN ADDITIONAL \$100.00 CHARGE.** PERMIT HOLDER RESPONSIBLE FOR ANY DAMAGES THAT MAY OCCUR.
